1. Call to Order

2. Notices and Communications- Lisa Hood came to let us know the legion project process.

3. Consent Agenda-

A. Approval of the minutes from January 14, 2019 Council meeting.

C. Court/Police- Andrew Stein spoke on our court system, about how we need to handle arrests and bonding, with court once a month. Limit municipal court to code violations and traffic, all other cases would be sent through county attorney. Mayor asked about not having anything in ordinance for theft of service, will check into and get clerk some options, but currently the PD can investigate the issue, and send to county attorney.

Chief Hager stated that car from KHP Lt. from dodge will be available in about 4 weeks. Car is well cared for, has been reserved for city.

Councilman Warden made a motion to approve purchase of the new patrol car for \$19,000.00 from KHP under a municipal lease through GNBANK Bucklin, for a term of 5 years, at 4.5% interest. Councilman Sellard seconded. Motion carried 4/0.

E. City Clerk- Councilwoman Davis has turned in her resignation for her position on city council.

Councilman Warden made a motion to accept the resignation of Stormy Davis. Councilman Sellard seconded. Motion carried 4/0.
