2. Notices and Communications- None.

3. Citizens Comments-Nancy and Katrina came to discuss a bill in their name for a property they own.

4. Consent Agenda-

A. Approval of the minutes from March 11, 2019 Council meeting.

B. Approval of Appropriations Ord. No. 942 for \$4,090.89.

Bostelmann made a motion to approve the consent agenda as presented. Knowles seconded. Motion carried 3/0.

C. Larry Cecil Building-2 bids-1 for entire building at \$12,500.00 & 1 for around windows, doors & garage doors, fix cracks & holes.

Warden made a motion to accept the bid for \$6,000.00 from Larry Cecil to repair the building. Bostelmann seconded. Motion carried 4/0.

7. Department Head Reports

A. Public Works- Konrade double checked rock price was \$20.00 hauled per ton.

Knowles made a motion to purchase 700 ton of rock from Ford Sand and Gravel @ \$20.00/ton, to be delivered by June 1. Jones seconded. Motion carried 4/0.

Maupins called on oil truck, extra \$600.00-\$800.00 to fix. Mower quotes back from BTI, 1 to fix deck and another to purchase and trade-in.

Bostelmann made a motion to repair the deck for \$1329.00 from BTI. Knowles seconded. Motion carried 4/0.

Pool paint to get 25 gal of pool blue is \$3000.00; 3 gal black \$345.00, total \$3345.00, through TeamLab. Mayor wants to check with MARC chemical. Tool box prices 56" bottom from Birney was \$1000.00.

Bostelmann motion to purchase Montezuma bottom box 56" for \$1000.00 from Birney Motor. Warden seconded. Motion carried 3-1 (Knowles abstained.)

Konrade checked legion foyer. Need professional to look at area that needs fixed. Knowles asked about Mark Davis checking roof for old heating vents, leaving pool of water in scout room. Need sealed/capped somehow.

B. Code Enforcement- several are being cited to come to court in May.

C. Court/Police-Chief Hager got car from Topeka, has most everything swapped over. Has PO for camera display, \$595

Warden made a motion to approve the \$595.00 for in-car camera display. Bostelmann seconded. Motion carried 4/0.

Checked a house last week, received a call from landlord of people being in it. Stopped 5 cars, issued 3-citations.

D. Fire Department- Warden said there was a small fire in Northend of town. 1-child locked in car. Has ISO ratings-Konrade did water testing on Wednesday, takes several months to come back.
