1. Call to Order
Mayor Fisher called the meeting to order at 7:00 pm.
Council Present: Cody Warden, Brian Bostelmann, and Luke Knowles. Absent: Shane Jones and Clay Sellard. City Staff present: Clerk Rikki Hager. Citizens Present: None.
2. Consent Agenda-
 - A. Approval of the minutes from May 14, 2019 Council meeting.
Warden made a motion to approve the consent agenda as presented. Knowles seconded. Motion carried 3/0.
3. Purchase requests and Items needing Council Action
 - A. Dog Ord. 884, Pit Bulls-tabled to June 10, 2019
 - B. Street Sweeper-Jason from Key Equipment was here to help with getting purchase complete. Sellard contacted Jason previously and asked about a service contract, would be \$3500.00 annually. When one of the 2 reps come around would inspect machine periodically at no charge. One year warranty for anything replaced on old one, and also on new one is bumper to bumper, unlimited hours and miles. Used machine comes with a free wrap, will come back 3-5 years, to cover wears on it. Will want piranha brooms.
Warden made a motion to approve the Pelican, with wrap and piranha brooms, for \$120,000.00. Bostelmann seconded. Motion carried 3/0.
 - C. Drainage on Washington Street- Knowles asked about drainage, contacting county about getting it to flow to the south ditch. Talk with county about what they are willing to do.
 - D. Dog Issue-Bostelmann got into a conversation with someone about a citizen bit by a dog. Citizens need to call 911 or 620-227-4646 for non-emergency and report the problem, so that our animal control can be contacted to make contact with owner.
 - E. Cameras-Mayor got a quote from TJ Milford for 6 camera system approx. \$2000.00 with computer, installation and etc. Mayor will check on other camera options. Warden asked how long DVR will hold. Options for dumpster were to remove them or put cameras up.
