1. Call to Order  
Mayor Fisher called the meeting to order at 7:00 pm.  
Council Present: Brian Bostelmann, Clay Sellard, Luke Knowles, Cody Warden joined the meeting at 8:27 pm. Absent: Shane Jones. City Staff present: Clerk Rikki Hager. City Maintenance Bud Green. Citizens Present: None.
2. Consent Agenda-
  - A. Approval of the minutes from May 28, 2019 Council meeting.  
Sellard made a motion to approve the consent agenda as presented. Knowles seconded. Motion carried 3/0.
3. Purchase requests and Items needing Council Action
  - A. Dog Ord. 884, Pit Bulls- Sellard listed some ideas for the minimum 50 sq. ft pen covered top 6 ft. tall, unable to dig out \$250.00 origination 1x then \$100 annual, 100k ins, 1 strike out aggression- if easy to catch gets 1 extra shot, vaccinations, random checks, owner lose animal will not be allowed to have another pit again, bring pit into town w/o rules \$500 fine, and 30 days to correct to keep and then follow rules, other members bring ideas next meeting.

Bostelmann motion to buy a load of  $\frac{3}{4}$  crushed washed rock, not to exceed \$600.00. Sellard seconded. Motion carried 3/0. Sellard would like to see mosquitoes sprayed 3x a week. Mayor shared the financing for the street sweeper. Mayor shared that the cameras dropped \$300 for 4 cameras to \$1700.00.  
Sellard made a motion to purchase 4 cameras not to exceed \$2000. Warden seconded. Motion carried 4/0.
