March 08, 2021

The City Council of the City of Bucklin, Kansas, met in regular session on March 08, 2021, at 7:00 p.m., in the Council Chambers at Bucklin City Hall, 117 West Oak Street, Bucklin, Kansas, with Mayor Sellard presiding. Present were Councilmembers Cody Warden, Kirk Esplund, Brian Bostelmann, and Toni Dome. Absent Kraig Lindsay. City staff present were City Clerk Rikki Hager, City Maintenance Justin Engel, Chief of Police James Hager. Others present Rachel Servis.

CALL TO ORDER

There being a quorum of Councilmembers present, the meeting was called to order by Mayor Sellard at 7:00 pm.

CONSENT AGENDA

Councilmember Warden motioned to approve the consent agenda.

the motion, the motion carried 4/0.

ITEMS OF BUSINESS

1. Keller Leopold Ins Renewal

Shop other insurance. Decline wrongful termination coverage.

2. Lifeguard Certifications and Renewals prepaid by City

Servis asked about certifications. Certifications are \$200.00, recerts are \$175.00.

Councilmember Warden motioned to pay half of new certifications at \$200.00 up front and then other half at end of summer as long as new guard stays through summer, and recertifications will be covered 100% at \$125.00.

Councilmember Warden motioned to hire Rachel Servis for \$13.00/hour as Pool Manager.
Councilmember Dome seconded.

Councilmember Bostelmann motioned to hire Arianne Servis and Ashleigh Mazarac @ \$8/hr as lifeguards.

Councilmember Esplund seconded.

With all of the Councilmembers voting in favor of
the motion, the motion carried 3/1-Warden
abstained.

Councilmember Bostelmann motioned to hire Samantha Towry, Emalea Warden, Dailyn Katz, Halie Feikert, at \$7.50/hr as lifeguards.
Councilmember Dome seconded.

With all of the Councilmembers voting in favor of the motion, the motion carried 3/1-Warden abstained.

Councilmember Bostelmann motioned to hire Waylon Dolezal, Jaron Lindsay & Mariah Stout at \$7.25/hr as lifeguards.
Councilmember Esplund seconded.

With all of the Councilmembers voting in favor of the motion, the motion carried 4/0.

Councilmember Esplund motioned to hire Zadien Pearce, Xavier Cid, Gunner Hearne, Ashlee Nagore for \$10/hour for part-time summer maintenance help.
Councilmember Bostelmann seconded.

With all of the Councilmembers voting in favor of the motion, the motion carried 3/1-Warden abstained.

5. Dogs-

Chief Hager, citizen reported they had a cat attacked and killed by 1 heeler dog with another dog that was running around with it. Bostelmann stated he was made aware of a pit bull at shop on oak.

Engel stated that they've been busy with oil changes getting ready for spring. Alley fixed behind Washington street. Victory electric trimmed trees in park last week. Filled potholes with winter mix. Dellinger swept. Used sand is now out at the dump. Concrete is being hauled off now. Justin and Jason will be gone 16 & 17 for water exam. Warden asked if paint has been ordered for pool. Would like filled halfway and try to get warm. Warden also discussed pool needs something done, in serious need of repairs. Find someone to patch holes. Sellard informed council he spoke with Stout about having others in a city vehicle. Sellard also stated that he's working with Chambre Brewer and Mollea Wainscott about KDOT grant.
