The City Council of the City of Bucklin, Kansas, met in regular session on August 09, 2021, at 7:00 p.m., in the Council Chambers at Bucklin City Hall, 117 West Oak Street, Bucklin, Kansas, with Mayor Clay Sellard presiding. Present were Councilmembers Cody Warden, Brian Bostelmann, Kraig Lindsay. Absent Kirk Esplund, Toni Dome. City staff present were City Clerk Rikki Hager, City Superintendent Jason Goracke. Others present Britt Sellard.

CALL TO ORDER

There being a quorum of Councilmembers present, the meeting was called to order by Mayor Sellard, at 7:00 pm.

PUBLIC HEARING

Mayor Sellard called the advertised public hearing for the 2022 Cemetery Budget to order at 7:00 pm. Receiving no comments, Mayor Sellard closed the public hearing at 7:15 pm.

Councilmember Lindsay motioned to approve the 2022 Cemetery Budget as certified.
Councilmember Bostelmann seconded.

With all of the Councilmembers voting in favor of
the motion, the motion carried 3/0.

CONSENT AGENDA

Councilmember Warden motioned to approve the consent agenda.
Councilmember Bostelmann seconded.

With all of the Councilmembers voting in favor of
the motion, the motion carried 3/0.

ITEMS OF BUSINESS

1. Water Dock-

Bid from Ben Vigness to replace water dock for \$5,300.00, other party will need to tear down and install electrical and spray insulation. Spray Foam was \$1836.94, Toby \$1500.00, total \$8636.94.

Councilmember Bostelmann motioned to replace water dock, not to exceed \$8700.00
Councilmember Warden seconded.

With all of the Councilmembers voting in favor of
the motion, the motion carried 3/0.

2. Library Appointment replacement for term ending 2023-

3. Economic Development Board Appointments.

Need 8 appointments-3 to a 1 year term ending 12/2021; 3 to a 2 year term ending 12/2022; and 2 to a 3 year term ending 12/2023.

4. Grocery Store

Brit Sellard shared some information on the process. Looking into a feasibility study, would like the City of Bucklin listed as the name on the study applications. Council agreed to let them use the name.

5. Code Enforcement-

DEPARTMENT HEAD REPORTS

Goracke stated that repaired dog pen that was damaged. Swept East side of town. Will be doing crosswalks and no parking areas prior to school starting. Trimmed trees on draws on west maple and elm. Spraying mosquitoes 2x week. Had a service line on West maple repaired today. Sewer ponds look good. Sellard asked to have them tested for discharge. Get a natural gas generator bid.

Councilmember Bostemann motioned for purchasing cellread endpoints, for \$25,680.00 from Badger Meter to replace current endpoints.

Councilmember Esplund seconded.

With all of the Councilmembers voting in favor of the motion, the motion carried 4/0.

COUNCIL UPDATES

Sellard will be speaking with owner of old hospital about removal of items on property. Deed is ready.

Lindsay stated a concerned citizen approached him over tethering in town. Provided copy of Dodge City and Greensburg, dog ordinances. Warden stated same citizen
