The City Council of the City of Bucklin, Kansas, met in regular session on March 29<sup>th</sup>, 2022 at 7:00 p.m., in the Council Chambers at Bucklin City Hall, 117 West Oak Street, Bucklin, Kansas, with Mayor Clay Sellard presiding. Councilmember Warden motioned to hire Aaliyah Goracke, Faith Mooney, Abigail Ogorzoka, Nick Feikert, Whitney Scott, Jordan Stimpert, as new Lifeguards in the amount of \$8.50 per hour Pending Certification.
