**CALL TO ORDER**

There being a quorum of Councilmembers present, the meeting was called to order by Mayor Sellard, at 7:00 pm.

**CONSENT AGENDA**

**ITEMS OF BUSINESS**

1. Summer help Application –

Councilmember Warden motioned to hire Kendell DeWeese starting immediately as summer help in the amount of \$10.00 per hour.

Councilmember Albert seconded.

With all of the Councilmembers voting in favor of  
the motion, the motion carried 4/0.

Councilmember Esplund motioned to give Gunnar Hearne a pay adjustment in the amount of .50 cents raising him from \$10.50 per hour to \$11.00 per hour.

the motion, the motion carried 4/0.

2. Lifeguard Certifications and Renewals prepaid by City

Servis asked about certifications. Certifications are \$210.00, recerts are \$90.00 per person. Councilmember Esplund motioned that every year the City would pay half of new certifications up front then the other half at end of summer as long as new guard stays through summer, and recertifications we be covered 100% every year.

Councilmember Albert motioned to hire returning Lifeguard Emalea Warden in the amount of \$9.50 per hour.

Councilmember Lindsay seconded

With all of the Councilmembers voting in favor of the motion, the motion carried 3/0 with Councilmember Warden abstaining.

4. Lochner Contract

### **City Clerk**

Kim will make up a form that Companies will fill out with all information needed for billing, and meter readings.

Councilmember Warden motioned to raise the cost for bulk water purchase from \$2.50 per 1,000 gallons to \$10.00 per 1,000 gallons.
